

In the fall of 2006, I came to Biel and sought work as a lecturer. At that time I already knew that there is an extreme feminism in Switzerland. Some of the women wants to rule over the men. To achieve this, they try to break the will of the boys. They use to, among others, psychological and sexual abuse. But at the unemployment office I was attacked by the right. They have made my documents disappear and harassed me. I fought with success. About it, there was an article in a left newspaper. This did not please the right.

Later I realized that in Biel for many years, there is a feminist regime. I have written this on the internet. This did not please the feminists. Now I was an enemy for the right and the left. I could not more find work, or was bullied after a short time.

In 2009 I noticed a pedophile group in Biel. When this group noticed it, they attacked me. They have started to watch over my communication (mail, internet). But that has not disturbed me. They wanted to intimidate me and have watching over me. They were afraid that I know too much.

I had to apply for social assistance because I could no longer find work. But the various groups in Biel (feminists, pedophiles, right) did everything to continue to suppress me. They wanted me to leave Biel. Sometimes they also have spread lies about me to rush other groups and the authorities on me.

2010 was the case Kneubuehl. A pensioner have wiped from the feminists and the authorities in the corner. He also knew what was going on in Biel. They have the police rushed to him because they knew he would fight back with violence. It was a trap. I've written about it on the internet. That did not appeal to all groups.

After the groups have tried to portray me as a madman. But they did not succeed. Unfortunately then my father died in January 2012. I sent him shortly before his death a letter to the hospital (Document 1). In it I wrote that I have a task for God in Biel. My informationwork was meant. My family and the authorities have abused this letter to bring me into psychiatry (Documents 2 and 3). They wanted to incapacitate me. My family so I do not heritage, the authorities that I was no longer believable. But it did not work.

After my release from the psychiatric they have still attacked me. They wanted to force me to Biel in the psychiatric treatment to incapacitate me. I refused. Then I found out from my disinheritance. My first attempt to fight back failed. In November 2012, I had left Biel and moved to my mother. I wanted at least to try it with her. But it dont work, she lied and deceived me constantly.

In February 2013, she wanted to extradite me back to the social authorities and to the psychiatry. So I decided to go away. My first stops were three Benedictine monasteries in Switzerland. There I was able to recover and had fought in the summer with the help of a lawyer my inheritance. At that time I was already in

Germany in a monastery as a volunteer. From there I traveled with some money to Ireland and then to the USA.

In the U.S., I'm trying to find a place where I can live in peace. But these groups from Switzerland continues to try to stop me. With the help of my lawyer, and many good people in the U.S., I have been able to resist. On 27. November 2013 I have to leave the United States.
