**Good day**

**As you have noticed from the mail traffic, the conversation between Mr. Bieri and me will probably not take place today. Beatrice Flükiger had contact with family members over the weekend. Apparently there's just no more warm familiar bands, the contact was broken long ago. A useful and usable power on the part of the family is not present. But true, concrete threats Mr. Bieri have not (yet) taken.**

But according to estimates by Ms. Flueckiger it could be possible, that "God" could instruct Mr. Bieri, "to do anything", which means "to eliminate evil people (authorities, suspected pedophiles, gays, etc.)", in the sense of a "sending".

Beatrice Flükiger and I have now agreed the following procedure:

The Canton Police will write to me as soon as possible a hazard message and ask to examine Mr. Bieri forensic psychiatric, to determine whether it could be expected of him physical violence, towards anyone.

It is still unclear whether the assessment is to be inpatient or outpatient. I tend to time on inpatient.

I will present Mr. Bieri by the police and then "feel" whether an outpatient assessment could be feasible. I will refrain from a prior formal invitation so he can not do the whole "internet" crazy before. That is just again a sign of power abuse by my side and water on its mills, "Biel scene" as he calls it. But otherwise it is unlikely to go.

So that any appeal has no prospect of success, I'm going to preview my actions with the head of the forensic psychiatric service and the FFE (*caring imprisonment*) Appeals Commission. A successful appeal against a FFE disposal by me / us would be probably the worst thing that could still happen.

Since I'm on vacation next week, I will unfortunately only can become active after (from 20 February).

If in the meantime the situation escalate, Regula Weissmuller, my deputy, will do a correct FFE , commit Mr. Bieri in the UPD Waldau (*psychiatric hospital*) and initially give a normal psychiatric evaluations in order. This we can then still convert to a "forensic" later.

P.S. the administrative court has already contacted me today, they have received a complaint against me. For this reason I am sending this email to the VG (*administrative court*) cc.
